Some Financial Secretaries are using Member Management partially for issuing 1st notices, but are not recording payments received and are not continuing the billing process for the year. - 5. Conversion to Member Billing for accounting and financial processing.** This presentation addresses the conversion to Member Billing for your accounting and billing responsibilities. It demonstrates creation of accounts using the format of the Faith in Action programs and greatly simplifies the budgeting and audit procedures.
